New gear has been ordered.

Will Morgan passed Fire I, and Nick Pica passed Fire Inspector Class.

Chief Asbrand asked for permission to purchase a new computer for filing reports. Chief Asbrand also asked to set up an account to repair pagers.

A motion to approve up to \$1000 for said computer, to set up the repair account, and approve \$800 for repairs was made by Bruch, seconded by Homa. All aye, motion carried.

A request was made by Gary Smith, Jamie Smith, and Nick Pica to attend the Engine Company Operations Class. Cost\$55 each. Motion to approve by Jones, second by Homa. All aye, motion carried.

A motion to approve a contract for \$1208 for service of Holmatro tools was made by Hlubik, seconded by Jones. All aye, motion carried.

As there was no further business, a motion to adjourn was made by Bruch, second by Jones. All aye. Meeting adjourned @ 8:52 PM.
